## **STANDARD TERMS AND CONDITIONS FOR WEDDINGS**

### **1) Confirmations**

- a) All reservations remain provisional until written confirmation has been received.
- b) A confirmed reservation, verbal or written, constitutes a binding contract.
- c) Written confirmation of a reservation is deemed to have been made at the time of despatch of the letter of confirmation. No employee or representative of ours has the authority to verbally confirm any reservation or to vary these terms and conditions.
- d) The hotel shall be entitled to treat the number of guests detailed in the clients reservation form as the minimum contractual number to be charged and catered for. Any reduction in numbers will incur the cancellation charges as detailed in clause 2.
- e) The amount payable by the client will be calculated on the contracted number or the number who actually attended, whichever greater.

### **2) Reduction in numbers**

Should you cancel or reduce the numbers for your booking a charge will be made, calculated as a percentage of the total booking value.

### **3) Deposits and Payment**

- a) A non-refundable deposit of £250.00 is required with all reservations.
- b) Full payment of the balance is required two days prior to the function.
- c) All extras and incidentals are to be paid on presentation of the bill on departure.

### **4) Damage**

The client is responsible to the hotel for any damage caused to the allocated rooms or the furnishings, utensils and equipment therein, or to the hotel generally by any act of negligence on the part of the client, sub-contractor, employee or guest of the client and shall pay the hotel, on demand, the amount required to make good or remedy such damage.

### **5) Corkage**

No wines or spirits may be brought into the hotel by clients or guests for consumption on the premises. All beverages must be purchased from the hotel.

### **6) Postponements**

Any postponements of confirmed and contracted business will be considered as a cancellation in accordance with Clause 2 above.

### **7) Non-Arrival Charges/Early Departures**

Bedrooms reserved in conjunction with the function are regarded as guaranteed bookings and in the event of non-arrival any additional nights for the reservation will be cancelled and appropriate cancellation charges will be levied as in Clause 2. The hotel reserves the right to charge for early departures as above.

### **8) Finishing Times**

Functions are required to finish at the time agreed on booking. Extensions are not possible unless previously agreed with the hotel Manager.

## **9) Health & Safety**

## **10) Statutory regulations**

The hotel has to comply with the Alcohol and Entertainment Licensing Act 2003 and the Regulatory Reform Fire Safety Order 2005. Accordingly we must ask all guests to keep fire exits free at all times. In case of a fire please follow the instructions of staff, noting the muster point is near the entrance to the car park.

## **11) Guests clothing and personal property**

We do not accept responsibility for the property of clients or their guests. Cloakrooms are provided, any goods left either in the cloakroom or unattended in other areas of the hotel are at the owners risk and the hotel is not liable for any loss or damage to the property. Insurers can be recommended to cover any function.

## **12) Equipment Storage**

The hotel will assist clients, where reasonably possible, with the storage of equipment etc. The hotel does not accept any liability for loss or damage to the equipment whilst being stored on the premises.

## **13) Professional Bodies and Performing Rights**

We reserve the right to object to the employment by clients and guests of any photographer, toastmaster, band or musicians in connection with any function, and will, without obligation, be pleased to give the benefit of our advice. It shall be the responsibility of the client to ensure that where applicable, Performing Rights Society forms and Phonographic Limited forms are completed by any band or musicians employed by the client.

## **14) Third Party Personal Insurance**

Clients may like to consider taking out an insurance policy to cover cancellation, damage, third party liability and any other eventuality beyond their control.

## **15) General Liability**

- a) We shall not be liable, whether in contract or otherwise for any indirect, consequential or economic losses or loss of profit howsoever arising (including negligence).
- b) In no event will our liability for any loss or damage in contract (including negligence) exceed the amount paid by the client for the function.
- c) We do not hereby exclude or restrict our liability in respect of death or personal injury from our negligence.

For all the time scales imposed by these conditions, time shall be of the essence.

## **19) Alterations**

It is the hotels aim to provide the client with the service they have requested for their function, but in the unlikely event that for any reason we need to change any aspect of the function we reserve the right to do so at any time. We will notify the client immediately so provision can be made to provide alterations of an equal or higher standard.

## **20) Governing Terms**

These terms and conditions shall apply to all contracts for provision of goods and services for conferences and weddings to the exclusion of all other terms and conditions including any which the client may purport to apply.

## **21) C.C.T.V**

Please note CCTV operates in and around the hotel.
